APA Task Force on Addressing Structural Racism Throughout Psychiatry Summary of Survey #3 Results Fielded October 5-23, 2020

Survey 3 was focused on racism in psychiatric practice. 566 people responded to the survey altogether, and their answers to eight questions are collated in the following.

Question #1: It has been said that structural racism operates at the macrolevel of societies systems, institutions, ideologies, and processes to reinforce inequities among racial and ethnic groups. Please select statements pertaining to structural racism in everyday psychiatric practice that you believe to be true for providers and for patients.

(Respondents were allowed to click more than one box)

The 75 respondents that chose to enter additional statements wrote about themes that varied greatly, but some emerging themes were socio-economic factors and access to care, mentions of other races and gender, the general acknowledgement that structural racism is a problem, and, conversely those that objected to the concept of structural racism.

QUESTION #6: Is there anything else you would like us to know about your experience with structural racism in your practice?

230 respondents offered answers to this question: 77 said they had nothing further to add. The rest of the answers varied in theme, 126 of the remainders used the space to reacknowledge the problem of structural racism or discuss specific manifestations thereof, while 27 used the space to question the concept of structural racism.
