## Approved Section 1115 Waivers – Focusing on Delivery System Reform and Behavioral Health (as of 02/2017)

As of February 2017, 33 states had 41 approved Section 1115 waivers. These waivers fall into 5 categories: delivery system reform; alternative ACA Medicaid expansion models; managed long-term services and supports (MLTSS) through capitated managed care; behavioral health, and other targeted waivers. Below are waivers in the first four categories.

New York is the only state using the waiver to implement a code for the Collaborative Care Model, but Maryland is considering how to implement codes through its waiver. See the section on "State Action on Collaborative Care" for more information.
